**KRyS GLOBAL'S FOUNDER & CEO SET TO RUN JUNGLE MARATHON FOR CHARITY**

*GEORGE TOWN, Grand Cayman (14 September 2011)* • KRyS Global announces it's Founder & CEO Ken Krys will take part in another running adventure for charity – the Jungle Marathon.

The Jungle Marathon ([www.junglemarathon.com](http://www.junglemarathon.com)) is set to take place from 6-15 October 2011 through the Amazon jungle of Brazil. Much like the Marathon des Sables Ken completed in 2009, runners in the Jungle Marathon are expected to be completely self-sufficient - bringing their own food, provisions, and even their own hammock to sleep in between the running stages.

Competitors have a choice of completing 110 km or 220 km in either 4 or 6 respective stages over the course of the week. Ken has chosen the longer distance of 220 km, which includes a grueling non-stop overnight stage of 89 km.

Through his participation in the Jungle Marathon Ken will be raising funds and awareness for the charity Facing Africa and for the NCVO.

Facing Africa is a charity dedicated to helping children in Nigeria and Ethiopia who suffer from a devastating disease called NOMA, which is an acute and ravaging gangrenous infection affecting the face. The victims are mainly children under the age of 6, caught in a vicious cycle of extreme poverty and malnutrition. Facing Africa provides funding for teams of volunteer surgeons to travel to Sub-Saharan Africa to perform facial reconstruction surgery on the victims of NOMA.
